MOHSIN): (a) to (d) Under the Scheme of National Overseas Scholarships to Scheduled Castes, Scheduled Tribes, Denotified, Nomadic and semi-Nomadic Tribes and other Economically Backward Classes, 28 students from various States have been sent abroad for higher studies during the last three years.

^Facilities to Converted Budhists

(b) The Constitution (Scheduled Castes) Order, 1950 as amended from time to time lays down that no person who professes a religion different from the Hindu or the Sikh religion shall be deemed to be a member of a Scheduled Caste, Accordingly, it is not possible to extend to the persons who have become converts to Budhism, the reservations
