BIR SINHA): (a) and (b). Government have received complaints regarding tax evasion in film industry. On the legislative side, on the recommendation of the Warichoo Committee, certain new provisions have been proposed in clauses 51 and 78 of the Taxation Laws (Amendment) Bill, 1973 which is currently pending before the Select Committee of the Parliament.

On the administrative side, searches of business and residential premises of some persons connected with film Industry were carried out by the Income-Tax authorities in Bombay in this connection. Consequential investigations are in progress.

Grant of pensions to ineligible persons in the Union Territory of Delhi

1781. SHRI O. P. TYAGI: Will the Minister of HOME AFFAIRS be pleased to

- (a) whether the Delhi Administration have received any complaints regarding the grant of pensions to freedom fighters who were not eligible;
- (b) if so, what is the number of such complaints received;
- (c) what action Government have taken thereon; and
- (d) whether Government have conducted any enquiry in the matter?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) and (b). The Delhi Administration have received 73 such complaints.

(c) and (d). The Delhi Administration have enquired into 31 cases and pensions have been suspended in all these cases. In the remaining cases, enquiries are being made and further action will be taken on receipt oX reports.

Coal Mining in Maharashtra

1782. SHRI K. N. DHULAP: PROF. N. M. KAMBLE:

Will the Minister of ENERGY be pleased to state:

- (a) whether it is a fact that the Maharashtra Government have sought the Central Government's permission to undertake coal mining in the Chanda Region in that State; and
- (b) 'if so, what decision Government have taken thereon?

THE DEPUTY MINISTER IN THE MINISTRY OF ENERGY (PROF. SIDDHESHWAR PRASAD): (a) and (b). The Government of Maharashtra had requested that the Maharashtra State Mining Corporation may be allowed to take up exploitation of coal in the Chanda coalfield to supplement the efforts of the Coal Mines Authority Limited and in particular to meet the coal requirements of a proposed thermal power station at Chandrapur. In view of the need for integrated development and for putting scarce financial and managerial resources to the best use, It has not been possible to agree to this request. It has teen confirmed that the coal requirements of the Chandrapur power station will be met by the Coal Mines Authority Limited who have already taken up the exploitation of the Chanda coalfield

Redemarcation of areas for Centralsubsidty to cover growth centres inBackward Areas
