Representation on persecution of Christians in Arunachal Pradesh

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) Yes, Sir.

(b) According to information received from the Arunachal Pradesh Administration, following tension between Christian and non-Christian groups in the Sagalee area of Subansiri district, a few clashes took place in April, 1974 and a few thatched houses were also burnt. Appropriate action was taken by the authorities concerned to maintain law and order and to provide relief to the affected persons. The situation in the area is reported to be peaceful.

Manufacture of Coal Mining Machinery

1757. SHRI KALYAN ROY: Will the Minister of INDUSTRY AND CIVIL SUPPLIES be pleased to refer to reply to Unstarred Question 827 given in the Rajya Sabha on the 18th May. 1970; and state:

(a) the types of coal mining machinery at present being manufactured by the Mining and Allied Machinery Corporation of Durgapur;

(b) the details of the various types of machinery which have been manufactured and supplied during the last three years till November, 1974, year-wise;

to Questions

- (c) to what extent it has been able to meet the requirements of the Coal Mines Authority and B.C.C.L.; and
- (d) by when it will be in a position to meet the entire demands of coal mining machinery requirements of the country?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY AND CIVIL SUPPLIES (SHRI A. C. GEORGE): (a) The types of coal mining machinery at present manufactured by MAMC are haulages, winders, mine cars and tubs, mine locomotives, hydraulic props, roof bars, pumps, booster fans, belt conveyors, armoured chain conveyor, coal cutting machines and coal drills.

- (b) Statement showing details of mining equipment manufactured and supplied during last three years is annexed.
- (c) and (d) when the previous Question was answered in May, 1970, most of the coal mines were in private sector and consequently the demand for mining equipment and machinery was limited. In that context, it was stated that the public sector undertaking would be able to meet the entire requirements of the coal mining industry of the country after it went into full production.

In fact due to inadequate orders for mining machinery and equipment, MAMC were attempting to diversify their production. Position has since changed in as much as most of the coal mines have been nationalised and reorganised. Owing to the oil shortage and emphasis on coal as energy source, the target for annual production of coal at the end of the Fifth Five Year Plan has been fixed at 135 million tonnes indicative of a nearly Ave fold rate of increase of coal production as
