- (a) whether it is a fact that a substantial amount remained unutilised out of the allocations made for the Union Territory of Delhi during the Fourth Five Year Plan period;
- (b) if so, what was the total allocation made and how much amount remained unutilised and what are the reasons therefor; and
- (c) what is the allocation for the Union Territory of Delhi for the first year of the Fifth Five Year Plan and what is the expenditure incurred in the first six months of the current year?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI VIDYA CHARAN SHUKLA): (a) and (b). The Fourth Plan of the Union Territory of Delhi was approved at Rs. 152.65 crores to be fully financed by the Centre. As against the approved outlay, the actual expenditure, as reported by Delhi Administration, amounts to Rs. 155.10 crores.

(c) The Annual Plan of the Union Territory of Delhi for 1974-75 was approved at Rs. 45 crores. According to the information furnished by Delhi Administration, the expenditure in the first six months of the current year is Rs. 10.56 crores.

(c) As on 31-10-1974, 4,24,901 registrations for Bajaj Scooters and 2,23,102 for Lambretta Scooters were pending.
