#### increase in the Prices of Foodgrains

300. SHRI SAWAISINGH SISODIA:  
Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state :

(a) whether Government's attention has been drawn to a news-item that appeared in the 'Indian Express' of 9th October, 1974 to the effect that foodgrains prices have registered an increase of 43.3 per cent over the year ending 24th August, 1974; and

(b) if so, the details in this regard and what steps Government have taken in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI ANNASAHAB P. SHINDE): (a) and (b). Government have seen the news-item. The All India Index Number of wholesale prices of foodgrains as on 24th August, 1974 registered an increase of 43.5 per cent over the corresponding index of last year.

As a result of corrective measures and stringent action against the hoarders and black-marketeers, the prices of foodgrains have shown a downward trend in the States and the availability has improved. The All India Index Number of wholesale prices of cereals fell 5.3 per cent between 28th September and 9th November, 1974 as against a rise of 5.7 per cent recorded during the corresponding period of last year.

**Meeting of the M.P. Ministers with P.M. for Greater Central Assistance**

302. SHRI MAHENDRA BAHADUR SINGH: Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

(a) whether it is a fact that a team of Ministers of the Government of Madhya Pradesh met the Prime Minister and the Union Agriculture and Irrigation Minister recently for greater Central Assistance for their drought-stricken State; and

(b) if so, the details thereof and what action Government have taken thereon?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI ANNASAHEB P. SHINDE): (a) Yes, Sir.

(b) The State Ministers requested that a Central Team should be deputed to visit Madhya Pradesh in order to assess the drought situation there and suggest what Central help should be given to the State. This request was accepted and a Central Team was duly sent to M.P. The report of the team is under the consideration of Government in consultation with the State Government.

**Development of Banana Production in Madhya Pradesh**

303. SHRI MAHENDRA BAHADUR SINGH: Will the Minister of AGRICULTURE AND IRRIGATION be pleased to refer to the answer to Starred Question 74 given in the Rajya Sabha on the 24th April, 1974 and state:

(a) whether the scheme for banana development in Madhya Pradesh covering 800 hectares of area in the first year of the Fifth Year Plan has since been approved by the Central Government;

tance given to that State in this respect; and  
(c) if not, reasons for delay in the approval?

THE DEPUTY MINISTER IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI PRABHUDAS PATEL): (a) and (b). A Centrally Sponsored Scheme for Package Programme on banana in Madhya Pradesh covering an area of 300 hectares in the first year of the Fifth Five Year Plan has been sanctioned at an outlay of Rs. 1.19 lakhs.

**Price of Sugar**

304 SHRI SANAT KUMAR RAHA: Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

(a) whether it is a fact that sugar prices in different States are uniform;

(b) if so, what is the present retail and controlled prices of sugar; and

(c) what is the prices of sugar—both ex-mill and ex-godown?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI SHAH NAWAZ KHAN): (a) and (b) The uniform retail price of levy sugar is Rs. 2.15 per kilogram all over the country, whereas the prices of non-controlled sugar in the open market in selected centres varied from Rs. 4.65 to Rs. 5.35 per Kg. as on 11.11.74.

(c) A statement showing ex-factory/godown prices statutorily fixed for levy sugar (D-29 grade) in different zones for 1973-74 production is attached.
