- 291. SHRI H. S. NARASIAH: Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:
- (a) whether it is a fact that the Karnataka Government has asked the Central Government to set up a grass seed production farm at Hessarghatta, near Bangalore with Australian assistance; and
- (b) if so, what decision Government have taken thereon?

THE DEPUTY MINISTER IN THH MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI PRABHUDAS PATEL): (a) No, Sir. The Government of India had requested the Government of Karnataka to offer suitable site for establishment of the Central Fodder Seed Production Farm and had suggested that the Hessarghatta site would be suitable for the purpose.

(b) The site is under consideration. Certain information from the State Government regarding the irrigation facilities at the site is being collected and a decision will be taken after examining the same.

(b) The Central Government will share in the Equity participation with the State Government on 50:50 basis in a year-to-year phased manner.
