

**Retrenchment in Beas Dam Project**

312. SHRI O. P. TYAGI: Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

(a) whether it is a fact that fifteen thousand project employees working at the Beas Dam are to be served with retrenchment notices by stages;

(b) the number of employees who have lost their jobs on 12th October, 1974;

(c) what steps have been taken by Government to provide these employees with alternative jobs; and

(d) whether any compensation is proposed to be given to those employees who are not absorbed in other jobs.

THE DEPUTY MINISTER IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI K. N. SINGH): (a) Out of about 14,700 workers employed on the Beas Dam Project, about 1,500 shall be needed for maintenance and operation on the final completion of the project and the rest have to be retrenched in stages.

(b) 2,156 workers were served notices and were to be retrenched between 12th October, 1974 and 11th November, 1974.

(c) Efforts are being made to find alternate jobs for these workers and as a result thereof alternate employment for about 50 per cent of the retrenched workers has been arranged.

(d) The retrenched workers are being paid retrenchment compensation in accordance with the rules.

**Deaths by Tubectomy in Safdarjung Hospital, New Delhi**

313. SHRI O. P. TYAGI: Will the Minister of HEALTH AND FAMILY PLANNING be pleased to state:

(a) the number of cases of tubectomy resulting in deaths while undergoing operation in Safdarjung Hospital, New Delhi during the months of August and September, 1974;

(b) whether it is a fact that the death of one patient Mrs. Panna Lal took place on account of post operation neglect; and

(c) if so, the details thereof and the action Government have taken against the persons found guilty of neglect?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY PLANNING (SHRI A. K. M. ISHAQUE): (a) None died while undergoing tubectomy operation.

(b) Enquiry in the case did not reveal any negligence.
