Sea-Erosion in Kerala

- (a) whether Government are aware that the sea erosion in Kerala coast is spreading to new areas and getting more and more intensified; and
- i(b) if so, the steps taken by Government to check sea erosion ?

THE DEPUTY MINISTER IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI K. N. SINGH): (a) and (b) The problem of sea erosion on the Kerala coast is well known. The State Government of Kerala, who are concerned with the planning and implementation of the protection works, have been executing a erosion measures since the First Plan. Since then a length of about IOO km, out of the total of about 320 km subject to severe erosion, has been protected up to the end of Fourth Plan with an outlay of Rs. 17.7 crores. Anti-sea erosion measures are being continued in the Fifth Plan, for which an outlay of Rs. 20 crores has been tentatively proposed.
