- (vii) adequate machinery for the health, residence and welfare for the students has either been provided in, or resources are being made available for the purpose to the University,
- (viii) the University has been provided with adequate facilities in respect of hostel and quarters, excluding buildings, staff equipments, books, library, colleges c slitutions affiliated or admitted tt*^ privileges, whose aggregate value vis not less than Rs. 2 crores along with the developed land or the State Government is prepared to •/we an assurance to the Commission that a minimum amount of Rs. 2 crores shall be made available to the Univer-* sity during the initial period of five years for the provision of the abovementioned facilities in addition to the developed Iand.

- (b) and (e). The following measures have been taken for promoting the cultivation of mushroom in the country:
 - (i) Cultivation of mushrooms bras been taken up 'under the M.F.A.L. project at Solan in Himachal Pradesh under which marginal farmers are being assisted with a subsidy of 33-1/3 per cent from Project funds on trays, sprayers and chemical ingredients for the first crop.
 - (ii) I.C.A.R, has set up a strong Research Centre on mushrooms at Solan. A number of training programmes for farmers and research workers has so far been carried out and guidance in the cultivation ot mushrooms is provided to the interested growers from this centre.
 - (Hi) Services of foreign experts on mushroom have been obtained through F.A.O. for research on mushroom growing including ihe training of research workers and farmers.
 - (iv) A project for the development of mushroom cultivation in Himachal Pra desh has been formulated for financial assistance from the U.N.D.P. This project is under examination of the Government of India
