#### Allocation of Land For Delhi College Building

305. SHRI S. A. HASHMI : Will the Minister of WORKS AND HOUSING be pleased to state :

(a) whether it is a fact that Government had promised about 6 years ago to allot 10 acres of land in the vicinity of walled city for the new building of the Delhi College;

(b) whether it is also a fact that so far this proposal has not materialised and the College is still functioning in the old, dilapidated and dangerous building; and

(c) if so, what steps Government propose to take to allot land for the College without further delay ?

THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUSING (SHRI MOHAN DHARIA) : (a) It was decided to allot about 7 acres of land at the junction of Jawaharlal Nehru Marg and Maharaja Ranjit Singh Road as per provision made for it in the Re-development plan of the Minto Road area by the Delhi Development Authority.

(b) It is correct that the proposal has not yet been materialised.

(c) Even though the site has been earmarked for the college, it will be made available only after the Primary Schools

of the Municipal Corporation of Delhi existing at the site have been shifted and the existing public road passing through the site is closed. However, at the request of the college, the Government have decided to hand over the existing ten bungalows on the site to the college on rental basis till the land is allotted to them.

#### Junior Scientists Working at the I.C.A.R. Headquarters

306. SHRI SUHRID MULLICK CHOUDHURY : Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state :

(a) the number of junior scientists in the field of veterinary sciences and cattle breeding working at headquarters of the ICAR for more than four years; and

(b) what are the reasons for not effecting frequent transfers of junior and assistant scientists between field stations research farms and desk work ?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION : (SHRI SHAH NAWAZ KHAN) : (a) Three junior scientists in the field of veterinary sciences and cattle breeding are working at the headquarters of the I.C.A.R. for more than four years.

(b) No system of transfers of scientific staff from the headquarters of the Council to the Institutes/field stations and vice versa exists, at present, in the Indian Council of Agricultural Research.

#### National Museum, New Delhi

307. SHRI BABUBHAI M. CHINAI : Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state :

(a) whether Government's attention has been drawn to a statement which appeared in the 'Indian Express' of 17th October, 1974, to the effect that the Director-General of West Berlin Museums is reported to have expressed the view that the National Museum in Delhi did not conform to international standards; and
