- 339. SHRI K. P. SINGH DEO: Will the Minister of EDUCATION, SOCIAL WEL FARE .AND CULTURE be pleased to state: •
- (a) whether Government have taken a final decision on building in Delhi a Sports Complex on Olympic pattern;
- (b) if so, the sports events for which tracks/sportsfields are to be provided;
- (c) the cost envisaged and by when the construction on the complex is likely to start?
- THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION AND SO-CIAL WELFARE AND IN THE DE-PARTMENT OF CULTURE (SHRI ARVIND NETAM) : (a) Yes, Sir.
- (b) and (c) The first phase of the project would consist of the development of the area including earth filling, construction of a covered stadium for various indoor games. Provision of a cycle track, parking area, internal roads, lawns etc. According to preliminary estimates prepared in 1971, the first phase would involve an expenditure of Rs, 253 lakhs (approximately). Construction would be started as soon as funds become available.

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION AND SO-CIAL WELFARE AND IN THE DE-PARTMENT OF CULTURE (SHRI AR-VIND NETAM): (a) Yes, Sir, in the 1974 Davis Cup Tournament.

(b) The All India Lawn Tennis Association has decided not to play in the Finals of Davis Cup 1974, against South Africa. This is in accordance with our National policy of total opposition to South African Government's policy of 'apartheid'.

# Erosion at Farakka

- 341. SHRI DWIJENDRALAL SEN GU PTA: Will the Minister of AGRICULTU RE AND IRRIGATION be pleased to
- (a) whether the Farakka Barrage is facing any threat because of river erosion;
- (b) what steps have been taken by Government to stop the river erosion at Farakka;

THE DEPUTY MINISTER IN THE MINISTRY OF AGRICULTURE AND IRRIOiATION (SHRI K. N. SINGH): (a) to BhState Government of West Bengal have implemented certain anti-erosion measures in the reaches most affected by erosion on the right bank of the Ganga down-stream of Farakka. An expenditure of about R?T170 lakhs has been incurred on these works since 1971. The erosion does not pose threat to the Farakka Barrage.

(d) Beginning from the Fourth Five Year SOCIAL Plan, Central assistance to the' States is given WELFARE AND CULTURE be pleased to in the form of grants and loans without being tied up to any scheme or Sector. The planning and implementation of anti-erosion measures form a part of the flood i control sector, which is the responsibility

of the State Government. As such the expenditure on anti-erosion works has been met by the State Government of West Bengal.

However, under entry 63 of List I of the Seventh Schedule, Parliament may by law declare an institution to be an institution of national importance. When an institution is so declared; Parliament has the exclusive power to make laws in respect thereof,

(d) and (e) Calcutta University, being State University, receives maintenance grants from the Government of West Bengal. It is, therefore, the responsibility of the State Government to take care of the financial difficulties of the University. For its development programmes, the University receives grants from the University Grants Commission, on the basis of an approved, pattern of assistance. 74 RSS/74—5
