- 1831. SHRI K. L. SHARMA: Will the Minister of STEEL AND MINES pleased to state:
- (a) the prospects of rock phosphate in Udaipur region of Rajasthan; and quantum of rock phosphate which is being imported at present;
- (b) the result of the examination regarding the use of rock phosphate conducted by the World Bank at the instance of the Government of India; and
- (c) what further action Government have taken on the basis of this report ?]

*[THE DEPUTY MINISTER IN THE STEEL AND MINISTRY OF MINES (SHRI SUKHDEV PRASAD): (a) Rock phosphate deposits have been discovered in Jhamarkotra, Maton, Kanpur, Karbariaka-Gurha areas of Udaipur district. During 1973, 8,75,000 tonnes of rock phosphate was imported.

(b) and (c) The feasibility report obtained through the World Bank, for the mining and beneficiation of the Jhamarkotra rock phosphate, is being further examined in all its technical and organisational aspects to enable investment decisions. Work on the preparation of a detailed project report for the mines is likely to be taken up shortly.]

Plying of DTC Buses from Moti Bagh

- (a) whether it is a fact that no bus operates from Moti Bagh in New Delhi for commuters going beyond the Central Secretariat:
- (b) whether it is also a fact that two buses, viz. 710 Green Line Service 7X which operate between Dhaula Kuan and Shadipur Depot do not stop at the midway stoppages;
- (c) if so, whether Government propose to introduce some buses from Moti Bagh on route numbers 9 and 15, which since been withdrawn, for commuters residing in Moti Bagh I and II, North-West Moti Bagh and in Sector 9 and 12 R. K. Purum, New Delhi; and
- (d) Whether Government propose to appoint inspectors to check plying of buses which do not stop at authorised stoppages?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING TRANSPORT (SHRI H. M. TRIVEDI): (a) and (b) No, Sir.

(c) Services on route No. 9 continue to operate from Moti Bagh to Regal during the rush hours. This colony and the areas adjoining it are also covered by a number of other routes operating towards Central Secretariat and beyond. The following seven special trips have also been provided from Moti Bagh to Regal for

Strike Notice in Durgapur Steel Plant

1833. SHRI MONORANJAN ROY: Will the Minister of LABOUR be pleased to state:

- (a) whether the Central Government had received strike notice of October 3, 1974 served by the CITU and AITUC Unions in Durgapur Steel Plant demanding the re-instatement of retrenched contract labourers in the plant; and
- (b) if so, what action Government have taken in this regard ?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR (SHRI BAL-GOVIND VERMA): (a) and (b) Industrial relations in the Durgapur Steel Plant come within the jurisdiction of the Government of West Bengal. According to the State Government report dated December 4, 1974, the unions had served notice for token strike on October 3, 1974, in support of their demand concerning reinstatement of 'Thikadar Mazdurs' working under cooperative societies and on their roll up to August 20, 1974. The State Industrial Relations Machinery held discussions with the parties. The State Labour Minister also met the representatives of the unions, the management of Durgapur Steel Plant and of the labour cooperative societies on October 16, 1974.

Issue(s) if any, which still remain outstanding could be brought by the aggrieved employees and their unions to the notice of the State Industrial Relations Machinery.
