- (a) The aggregate target of production of steel from the integrated steel plants at Bhilai, Durgapur Rourkela and Bokaro and of TISCO and nSCO for the year 1974-75 is 6.575 million tonnes of ingot steel and 5.044 million tonnes of saleable steel.
- (b) The production during, the months, April—November, 1974, was 95.4 per cent and 99.0 per cent of the targets for ingot steel and saleable steel respectively for this period. It is, therefore, expected that the target for the whole year 1974-75

might be achieved by the end of March, 1975. Central Loan Assis provided the requirements of inputs, power and transport are met adequately in the remaining months.
