#[Production capacity of Steel Plants

\*805. SHRI PRAKASH VIR SHASTRI: Will the Minister of STEEL AND MINES be pleased to state:

(a) whether the installed capacity of steel plants is not being fully utilised and if so, what is the loss in production as a result thereof; and

(b) what is the percentage of unutilised production capacity of Bhilai, Durgapur, Rourkela and Bokaro plant?]

इस्पात और खान मंत्रालय में राज्य मंत्री (श्री चन्द्रजीत गाद्व): (क) और (ख) एक विवरण सभा पटल पर रख दिया गया हॉ ?

## विवरण

(क) भिलाई. दुर्गापुर, राउरकेला, टिस्को ऑर इम्को पंच सर्वतामुखी इस्तात कारखानो की कुल अधिष्ठापित वार्षिक क्षमता 89 लाख टन इस्पात पिण्ड ऑर 67.29 लाख टन तिकेय इस्पात की हूँ। वर्ष 1974-75 के लिए इन कारखानों के कल उत्पादन का लक्ष्य जिसके प्राप्त हो जाने की आशा हूँ 64.55 लाख टन इस्पात पिण्ड और 50.44 लाख टन विकेय इस्पात हूँ। इस लिए शीधष्ठापित क्षमता की तुलना में वर्ष 1974-75 में अपर्युं क्त क्षमता की तुलना में वर्ष 1974-75 में अपर्युं क्त क्षमता की कारण हुई उत्पादन की हानि 24.45 लाख टन पिण्ड और 16.85 लाख टन विकेय इस्पान बठती हूँ। फिर भी सत्तत आधार पर अधिष्ठापित क्षमता का 100% उप-योग करना कठिन हूँ और सामान्यतः क्षमता का 90% उपयोग संतोषजनक माना जाता हूँ। (ख) इस के आधार पर कि वर्ष 1974-75 के लिए निश्चित किये गये लक्ष्य प्राप्त हो जाएंगे इस वर्ष भिलाई, दुर्गापुर और राउस्केला के इरगत कारखानों में अपर्यन्नित अधिष्ठापित क्षमता इस प्रकार होगी :---

(THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI CHANDRAJIT YADAV): (a) and (b) A statement is laid on the Table of the House.

#### Statement

(a) The aggregate annual installed capacity of the five integrated steel plants of Bhilai, Durgapur, Rourkela, TISCO and HSCO is 8.9 million tonnes in terms of ingot steel and 6.729 million tonnes in terms of saleable steel. The total target of production for 1974-75 for these plants which is likely to be achieved is 6.455 million tonnes of ingots and 5.044 million tonnes of saleable steel. Accordingly, with reference to the installed capacity, the loss of production on account of unutilised capacity in 1974-75 works out to 2.445 million tonnes of ingots and 1.685 million tonnes of saleable steel. However, 100 per cent utilisation of installed capacity on a consistent and continuing basis is difficult and generally 90 per cent utilisation of capacity is considered satisfactory.
