## WRITTEN ANSWERS TO QUESTIONS

### Construction of a cinema house in Chittaranjan Park Kalkajec, New Delhi.

783. SHRI DWIENDRALAL SEN GUPTA: Will the Minister of SUPPLY AND REHABILITATION be pleased to state :

(a) whether any cinema house has recently been constructed in the Chittaranjan Park, Kalkajec, New Delhi in an area allotted to the erstwhile East Bengal refugees:

(b) if so, whether such construction was duly authorised;

(c) if not, what steps Government propose to take to prevent the unauthorised construction of the cinema;

(d) whether Government are aware of the resentment, of the residents of the Chittaranjan Park over the construction of the cinema house; and

(e) what is the name of the owner of the said cinema house ?

THE MINISTER OF SUPPLY AND REHABILITATION (SHRI R. K. KHA-DILKAR) : (a) No, Sir. But a cinema house has come up adjacent to the Colony limits.

(b) to (e) The matter is being looked into.

### Transshipment of coal from Calcutta to West Coast

787. SHRI LOKANATH MISRA : SHRI K. P. SINGH DEO • SHRI M. P. VARMA :

Will the Minister of SHIPPING AND TRANSPORT be pleased to state :

(a) whether Government are aware that shipping companies carrying coal from Calcutta to West Coast lose on an average between 3 to 4 lacs of rupees per ship;

i(b) whether Government are also aware that some shipping companies are not undertaking coastal traffic and if so, whether Government propose to take any steps against such shipping companies; and

(c) whether Government propose to revise the freight rates so that the shipping companies do not lose on such coastal traffic ?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI KAMALAPATT TRIPATHI) : (a) It is a fact that shipping companies operating on the coastal trade are inclining losses. But, such loss are generally computed by the companies over a period of time in respect of their fleet as a whole and not on individual shipwise basis.

(b) Though the shipping companies are reluctant to operate on the coast, they have been persuaded to undertake coastal voyages depending upon the need and availability of cargoes.

(c) Government is seized of the whole matter with a view to evolving a rational and economic structure for freight and other issues concerning the coastal trade.
