Only a few units of Bokaro Steel Plant have been commissioned so far.

(b) None of these plants is presently working to its full installed capacity. The lower utilization capacity at these plants during the last few years has been due to a variety of reasons differing from plant to plant and often from year to year. Broadly speaking, the main factors were: the unsatisfactory working of coke oven batteries; back-log maintenance inadequate tenance leading to equipment troubles and break-downs; collapse of the steel melting shop roof of Rourkela Steel Plant in July, 1971, affecting the operation of the entire steel plant for several months; inadequate replacement, repairs and maintenance programmes in IISCO; disturbed industrial relations, particularly in Durgapur Steel Plant and IISCO and to some extent in the Rourkela Steel Plant: power restrictions/failures and severe power cuts interruptions: inadequate availability of coal, and serious dislocation in rail movement on account of intermittent slow down and industrial unrest in the ways in 1973-74. In the current financial year, the production at these plants had to be regulated and kept low during the months, April-June. 1974, with a view to conserving stocks of raw materials, first on account of the possibility of the strike by the Railway employees and then on account of the strike itself and its aftermath. There have been certain difficulties in regard to supply of power and coal also].

The number of operators who have not renewed their counter-signatures is not readily available with the Ad-The Administration ministration. propose to take up the matter with States concerned to increase the quota of tourist vehicles to be operated under counter-signatures, if the number of pending applications exceeds the number of vacancies.

# Indo-Pak relations

- 443. SHRI BABUBHAI M. CHINAI: Will the Minister of EXTERNAL AF-FAIRS be pleased to state:

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI BIPINPAL DAS): (a) The Prime Minister of Pakistan is reported to have made statements Pakistan was ready to hold talks on Kashmir with India under the Simla Agreement.

(b) India's stand on Kashmir and the Simla Agreement is well-known. The Simla Agreement envisages bilateral discussions on Kashmir after implementation of normalisation measures and in the context of the establishment of durable peace. As House is aware, talks on the implementation of normalisation measures are vet to be completed.

# Reaction of neighbouring countries on associate Status to Sikkim

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI BIPINPAL DAS): Except for China, Pakistan and Nepal no other neighbouring country has reacted adversely to Sikkim being associated with the Union of India. The reaction of China and Pakistan has been hostile. In Nepal, after an initial, adverse reaction, there is a somewhat better understanding of the situation.
