The additional foreign exchange outgo on account of the above increase will be of the order of Rs. 12 crores during 1974-75. In view of the foreign exchange constraints additional foreign exchange arising out of these price increases may not become available. The import of crude oil during 1974-75 will therefore be less by about 194,000 tonnes but this is not likely to have any appreciable effect on the country's total requirements of the crude oil. SCARE JN RAILWAY PASSENGERS IN EASTERN INDIA

514. SHRI KALYAN ROY: Will the Minister of RAILWAYS be pleased to state

- (a) whether Government are aware of the scare among passengers travelling in trains in Eastern India, particularly in and around Calcutta because of large-scale-thefts, looting, dacoity and murders of passengers;
- (b) the number of such incidents which took place in various trains in last six months; and
- (c) the steps taken by Government to check them "and results thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS: (SARDAR BUTA SINGH): (a) Yes. the Government are aware of some increase in crime against person and property of passengers in the area. However, no scare is noticeable on this account among /! igers.

- (b) 4 cases of murder, 32 cases of robbery, 15 cases of dacoity and 418 cases of thefts of passengers, property took place during the period May-October, 1974 in the West Bengal portion of the Eastern, South-1 astern and Northeast Frontier Railways.
- (c) Such cases come within the purview of law and order. 'Police including Railway police' being a State subject, the State Governments are taking necessary steps to control such crimes in railway trains with in the means available at their disposal by way of escorting important trains at night, shadowing suspects by armed police in plain clothes in West Bengal area, posting of regular beat patrols at station platforms and waiting halls, keeping veillance over criminals and known bad characters, prosecuting criminals for specific offences under the preventive laws.
