DELAY IN COMMISSIONING OF HALDIA
REFINERY PROJECT

## 501. SHRI INDRADEEP SINHA: SHRI LAKSHMAN MAHA-PATRO:

Will the Minister of PETROLEUM AMD CHEMICALS be pleased to state:

- (a) whether the commissioning of the Haldia Refinery will be delayed further;
- (b) if so, the reasons therefor, and when it is expected to be commissioned;
- (c) whether it is a fact that due to this delay the refinery has been facing serious losses, since the entire administrative and refinery staff has already been recruited; and
  - (d) if so, the facts thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI C. P MAJHI): (a) and (b). The trial runs of the Distillation Unit of the fuel sector commenced during the end of August, 1974. The unit operated with minor interruptions and there was a planned shut down towards the end of September, 1974 to prepare for the next phase of trials. Presently the testing of various equipment and loading of reactors of the Catalytic Reforming in progress. Unit are The Catalytic Reforming Unit would be put on\* trial runs shortly; on stabilising the operations of this unit, the Distillation Unit will also be started and both units will run on guarantee tests for three to four weeks during December, 1974. The lube sector is expected to be commissioned by end of 1975. Delay in the completion schedule of the Visbreaker Unit and the various units of the lube sector to delay in the receipt of the equipment from foreign suppliers, scarcity materials etc. of construction have contributed to the delay in the commissioning of the units.

(c) and (d). In a complex project like a Petroleum refinery, positioning of the operation staff in advance of the commissioning would be essential so that the staff get acquainted with the units during precommissioning tests and trial runs. Therefore, the expenditure towards staff prior to commissioning cannot be considered as a loss.
