*297. SHRI NIREN GHOSH: Will the Minister of PETROLEUM AND CHE-MICALS be pleased to state:

- (a) whether the two American oil companies which were given contracts for offshore exploration in Bengal have begun exploration operations;
 - (b) if not, what are the reasons therefor;
- (c) whether those companies have conducted seismic surveys on their own; and
- (d) whether Government propose to utilise the data of seismic survey supplied by the Soviet Union earlier?

THE MINISTER OF PETROLEUM AND CHEMICALS (SHRI K. D. MALA-VIYA): (a) to (c). In May, 1974 two contracts were signed, one with M/s. Carls-berg India Group and the other with M/s. Reading & Bates Oil and Gas Co. Group, for off-shore exploration and production in the Bengal and Kutch basins respectively. Exploration operations, in both the off-shore areas by way of seismic surveys have already been started by the two groups of companies through their sub-contractors.

(d) The seismic data which have been obtained through the Soviet Seismic Survey earlier will be made use of by the ONGC.

MAIL TRAIN RUNNING BETWEEN MAHUVA AND DHASA

- (a) whether it is a fact that mail train running between Mahuva and Dhasa has been suspended;

(b) and (c). There are two pairs of passengers and one pair of mixed trail. scheduled to run on Dhasa-Mahuva section. 305/306 passenger trains have been suspended since 4-12-1973 on account of coal shortage. The restoration of these trains will be considered as and when coal position improves and stabilises at a reasonable level.
