Naga Rebels

355. SHRIMATI LAKSHM1 KUMARI CHUNDAWAT: Will the Minister of HOME AFFAIRS be pleased to State:

- (a) Whether Government's attention has been drawn to a news report which appeared in the Times of India' of 14 October, 1974 to the effect that Naga rebels are forcing young men and women to join their ranks;
- (b) if so, what are the details thereof; and
- (c) what action Government have taken in this regard?

THE MINISTER OF HOME AFFAIRS (SHRI K. BRAHMANANDA REDDY): (a) to (c) Government have seen the press report. Government are aware of the attempts macie by the Naga underground to recruit Young-men and women against their wishes to augment the depleted strength of the rebels. According to the information received from the State Government, 41 persons including 8 girls are known to have been so recr u ited during th period from August to October, 1974. State Government have also informed us that district authorities have been instructed to take all precautionary measures to prevent forcible recruitment and also take suitable action to get persons so recruited released. It has also been reported by the State Government that release of 3 persons including 2 girls had been secured by the district a uthorities. Some of them escaped from underground custody. The pressure of security operation against the underground is being kept up and this will have its own effect in deterring the underground from indulging in forcible recruitment.

#### Action against bogus industrial units

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY AND CIVIL SUPPLIES (SHRI A. C. GEORGE): (a) and (b) According lo the protocol of the Inter-Governmental indo-Soviet Commission on Economic, scientific and Technical Cooperation signed in Moscow in September, 1974, a Soviet team of experts is expected to visit India within six months from the date on which the protocol was signed. The Team of experts is expected to jointly study with the Indian experts specific arrears of cooperation in Industrial projects in third countries and prepare concrete recommendations for the consideration of the respective Governments. This team is expected to arrive in this country within the next few weeks.

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that two American nationals, Dr. Siedensticker, and Mrs. Anne Wright stayed for many days during August-September, 1974, Sundarbans in West Bengal along the strategically important coastal area;
- (b) whether it is also a fact that a U. S. Embassy photographer accompanied them;
- (c) if so, what are the details thereof? THE MINISTER OF HOME AFFAIRS (SHRI K.BRAHMANADA REDDY): (a) to (c) In August, 1974 Dr. Seidensticker, an American national who was in Nepal, visited Sunderbans at the instance of Mr. Anne Wright a British national in Calcutta who is an executive of the International wild life Association, to deal with a menacing tiger which was causing havoc in the Sunderbans area.

His visit was with the knowledge of the Government of West Bengal and he was also accompanied by some officers of the Forest Department of the State Govenment. Two photographers of the U. S. I. S. also accompanied the party.

The tiger was tranquilised and captured during the night of 25th and 26th August,

Dr. Seidensticker came to Calcutta on 13-8-1974 and was granted tourist facilities for 28 days.
