**REFERENCE TO SINE DIE AD-  
JOURNMENT OF THE NAGALAND  
LEGISLATIVE ASSEMBLY**

SHRI KHYOMO LOTH (Naga-land): Mr. Chairman. Sir, it has become necessary for us to have a discussion on the present situation that has been created in Nagaland, by the decision of the Speaker of the Nagaland Legislative Assembly to adjourn the House *sine die* in the midst of the Budget Session. This has created a constitutional crisis. Sir, it has become necessary for us to have a discussion because lobbying is going on in this House as well as outside this House for President's rule in Nagaland.

MR. CHAIRMAN: Now I am telling you. I have received notice and for tomorrow it is allowed for Calling Attention.

SHRI SUBRAMANIAN SWAMY: Sir, I agree to your suggestion to raise it on grounds of Calling Attention motion. It is there tomorrow but that is not my case. As far as he is concerned, we would like to hear what is going to happen because twenty-four hours is a very long time.

MR. CHAIRMAN: Mr. Swamy, he had met me in my Chamber and I have allowed it and he had accepted. Why are you raising it again? He had come and accepted. Why are you raising it unnecessarily when there is nothing?

SHRI SUBRAMANIAN SWAMY: I think the Calling Attention \_\_\_\_\_

MR. CHAIRMAN: No, please.

SHRI KHYOMO LOTH: After meeting you I have come to know that the Governor is going to take a decision by this evening. And lobbying is going on even now for President's rule. That I have come to know after meeting you... *(Interruptions)*... There is a new development. There is lobbying going on.

MR. CHAIRMAN: Calling Attention. Mr. Prakash Vir Shastri.

SHRI KHYOMO LOTH: Sir, please give me a chance.

SHRI JAGDISH PRASAD MATHUR: Point of order. President's rule is going to be imposed.

MR. CHAIRMAN: Who knows what is going to happen? I do not know what is going to happen. Why are you presuming?

SHRI KHYOMO LOTH: Sir, S. C. Jamir has to prove his strength in the House.

SHRI KHYOMO LOTH: I have every right to speak because Nagaland is one of the States in the Indian Union.

*(Interruptions.)*

MR. CHAIRMAN: What am I to do? You are not allowing him to be heard.

SHRI KHYOMO LOTH: Sir, on the 8th Mr. Vizol learned that his Party number was reduced to a minority. He readily accepted this and in consultation with the Government he tendered his resignation according to democratic and constitutional principle. But what happened, when he was able to mobilise the opinion of the members and get a majority, he along with the opposition leader, Mr. Jamir, went to the Governor and discussed the matter with him and demanded that UDF should be allowed to form a new ministry. Now the Governor has asked Mr. Jamir, the leader of the UDF legislative Party to prove his majority in the House and this was agreed to. Now it is written in the

paper, I will quote: The Assembly premises was heavily guarded by armed police and no visitors including newsmen were allowed to enter. Though the members were there inside the Assembly premises, what happened, the Chief Minister himself created a situation in the House and the Speaker in the midst of this budget session, without passing the budget, has adjourned the House *sine die*. not to speak of giving H. V. J amir to prove his party strength on the floor of the House. Is it a new thing in the history of parliamentary democracy? He is the guardian of parliamentary democracy and he is supposed to guard the constitutional provisions but today he has stabbed the democratic system and it is very unfortunate that this thing has happened. *(Interruptions)* Now the Governor has to order the Speaker to call the Assembly. I am not concerned with whosoever party comes into power but they must be given a proper chance to prove on the floor of the House as to who commands the majority. That I demand and I demand a parliamentary probe into the fact as to who has engineered the toppling of the Vizol government. Is it engineered from here or from this House or by the security forces are involved in it?

HON. MEMBERS: The Home Minister, Shri Om Mehta, is here. He should give a statement.

*(Interruptions)*

SHRI KHYOMO LOTHAS: I want an assurance.

MR. CHAIRMAN: Mr. Prakash Veer Shastri, on your suggestion I have heard him. What more can I do?

SHRI KHYOMO LOTHAS: I quote the statement of Mr. Vizol. He says that five MLAs were kidnapped by the opposition with the help of security forces.

MR. CHAIRMAN: Please resume your seat.

SHRI KHYOMO LOTHAS: Our democratic system is in danger. What will happen to the democracy of India if it happens in Nagaland also?

MR. CHAIRMAN: Are you not going to resume your seat? Please resume your seat.

SHRI SUBRAMANIAN SWAMY: The Minister should give an assurance.
