THE MINISTER OF COMMERCE AND INDUSTRY (SHRI MURASOLI MARAN): (a) and (b) Yes Sir. In the absence of processing unit in the area, the green leaves are sold to nearby Tea factories in west Bengal to get remunerative price.

(c) The District Authorities in Kishanganj are looking after tea development activities (under the guidance of Tea Board). The Tea Board has appraised the District Administration of the need for setting up processing units under Co-operative or State Government Sector. Tea Board, under the existing schemes provide long term loan for setting up of processing units in the co-operative sector and subsidiary of Rs. 40,000/- per hectare to the needy fanners for plantation activity.
