THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI C. P. MAJHI): Yes, Sir, The ONGC have released one location on Bakultala structure and two on Galsi structure. Drilling at Bakultala is expected to start this year.

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI BUTA SINGH): (a) Yes.

(b) No. Kasganj-Agra Fort section is at present served by 2 pairs of Express trains namely 11UP/12 DN Kumaon Express and 13UP/14 DN Agra Express and one pair of passenger train, There is no traffic justification for introduction of an additional Express train on this section as even the existing services on this section are not fully utilized.

## Supply of Stationery to Railway Staff

- (a) whether his attention has been drawn to the non-supply of pencils, tumblers and drinking water to the staff of the Southern Railway Reservation Office at Madras Central Station; and

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI BUTA SINGH): (a) and (b). A reference was received from Shri Samar Mukherjee, M. P. in 1974 about nonsupply of pencils and tumblers to the staft of Southern Railway Reservation Office at Madras Central station that arrangements for supply of drinking water by providing earthern pots were inadequate. Enquiries, however, reveal that the staff are being regularly supplied with pencils and tumblers and that adequate earthern pots for storing drinking water are available in the Reservation Office.
