(b) The countries from which the participants took part at the Conference are: Argentina, Australia, Austria, Bangladesh, Belgium, Canada, Egypt, Finland, France, Federal Republic of Germany, German Democratic Republic, India, Indonesia, Iran, Italy, Japan, Korea, Mauritius, Sri Lanka, Nepal, Netherlands, New Zealand, Norway, Pakistan, Philippines, Spain, Sweden, Switzerland, Tanzania, U.K., U.S.A., U.S.S.R., Yemen, Yugoslavia, and Zambia.

(c) According to the organisers of the Conference the resolutions passed at the Conference are not available with them as these were moved in draft form at the closing Plenary Session by the Chairmen of various Committees and all papers in this connection have been taken away by the Headquarters of the Association for further processing and will be issued by the Headquarters only after approval at the next meeting of the Executive Council of the Association to be held in London in May, 1975.

Namrup Fertilizer Project

(a) whether the Namrup fertilizer project has been completed and commissioned;

(b) if so, when and what is the total cost involved therein and how it compares with the original estimated cost of the project; and

(c) the reasons for such a large increase in the cost of the project?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND

CHEMICALS (SHRI K. R. GANESH):

(a) The mechanical erection of the Namrup Fertilizer Project has been nearly completed and pre-commissioning operations are in progress.

(b) As against the original estimates of Rs. 29.46 crores, the present estimated cost of the project is Rs. 58.62 crores.

(c) The over-run in the cost of the project is mainly due to the delay in completion on account of slippages in the delivery of equipments and in construction activity and due to the general escalation in prices during the intervening period.

(c) whether it is also a fact that because of financial stringency the Gorakhpur fertilizer unit has not been able to pay its own bills for power, coal, freight, etc.; and

(d) what steps have been taken to remedy the situation?
