Snapping of A.C.R.S. wire

- (a) whether it is a fact that about 65,000 metres of A.C.R.S. wire have been snapped by thieves from the telegraph lines in the Kanpur-Achhnera section of Northern-Eastern Railway during the year 1974;
 - (b) if so, what are the detai s thereof; and
- (c) the measures taken by Government to catch the culprits and the action taken against them?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI BUTA SINGH): (a) and (b). Yes, 57,980 metres of A.C.R.S. wire valued at about Rs. 34,014 was stolen from the telegraph lines between Kanpur-Achhnera Section of the North-Eastern Railway during 1974.

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM CHEMICALS (SHRI C. P. MAJHI): (a) and (b). The nylon textile spinning units could operate at capacity utilisation levels of 78 per cent in 1973 and 64 per cent in 1974, mainly due to restricted availability of the main raw material-caprolactam. The indigenous production of caprolactam commenced only in August, 1974 but due to certain teething problems, the production was only about 2,800 tonnes upto the end of 1974. However, the availability of caprolactam is expected to improve considerably this year and the difficulties of the industry in this regard would be mitigated.
