SHRI MAHAVIR TYAGI: Therefore, my submission, my humble submission, is that if there is anything repugnant to the general rights of citizens in any State, this Council of Ministers has a right to raise that question and discuss it. I felt like that... (Interruptions)... You kindly re-consider the matter, and I will again look into it tomorrow or the day after (Interruptions.)

REFERENCE TO ALLEGED STARVA-TION DEATHS IN PURULIA DIS-TRICT IN WEST BENGAL

SHRI MONORANJAN ROY (West Bengal): Sir, in Purulia district in West Bengal, it is reported that at least nine deaths have taken place due to starvation in nine villages alone. It is not an official figure. In that district, having a population of 16 lakhs, 5 lakhs and 12 thousand persons are agricultural labourers who have no means of livelihood, except grass and roots, upon which they are living now. Sir, in the same district, which was known as the granary of West Bengal and was self-sufficient in the production of paddy, there is now extreme drought. The situation has become such that it reminds of the 1943 Bengal famine. This is the observation made by different persons in West Bengal and different papers. Sir, the Minister himself with regard to another district, has said that in that district two lakhs people do not get one meal in a week. The Minister is Mr. Zainul Abadin. This is their admission in Midnapur District living on grass and roots. The whole State is under famine condition. The people are not in revolt. That is the. observation made by the Prime Minister. When she went to Howrah a few months back, she in her wisdom gave a speech. In that she said that though in 1943,

35 lakhs people died of starvation, but they did not revolt. That is our tradition. Yes, they did not revolt in 1943. but they revolted in 1945. I would like to remind the Government and the Prime Minister that if the situation is allowed to drag on like that, if famine is allowed to spread in the entire State and hundreds are allowed to die of starvation, there will be a revolt, and no one can stop that. That is my warning, Sir. No food has been rushed to those areas. One thousand women gheraoed the BDO, and it continues. This is the condition. What can the poor BDO do, unless food is rushed to that area? The Food Minister comes here and gives a statement which is absolutely wrong. Under these conditions I again remind the House and the Government that things will not be allowed to go on like that.

SHRI NIREN GHOSH (West Bengal); One word only ...

MR. CHAIRMAN: No, the practice must be followed. Now, Mr. Rabi Ray.

SHRI NIREN GHOSH: Only one word I want to add ...

MR. CHAIRMAN: This practice is not followed.

SHRI NIREN GHOSH: I am sure that 1943 will recur again in Bengal and lakhs will die of starvation ...

MR. CHAIRMAN: I have called Mr. Rabi Ray. You please sit down.

SHRI NIREN GHOSH: Whether the country is aware of it or not, I do not know.

यह है कि जब कोई रिफरैन्स यहां आता है तो उसका रिप्लाई नहीं मिलता है इससे यह होता है कि जो रिफरैन्स यहां दिए जाते हैं उससे देश को एक तरफ की इन्फरमेशन मिलती है। मेरा प्रस्ताव यह है कि अगर कोई रिफरैन्स आपको एलाट करना होता है तो मिनिस्टर कंसने से उसका रिप्लाई दिलवाया जाना चाहिए ! वरना गलत फहमी पैदा हो जाती है। लोगों को देश के बारे में फैक्ट्स का पता नहीं चलता, स्थिति की सही जानकारी नहीं मिलती। इसलिए आप कंसनं मिनिस्टर को बलवाकर उसको एकजामिन करवाया करें।

MR. CHAIRMAN: I will consider how the procedure should be adopted. The practice here is only one Member would raise an issue. But now a number of Members are raising the same thing. Therefore, I will have to consider whether I should continue this practice or not.

REFERENCE TO **FAMINE** CONDI-TIONS IN ORISSA

श्री रबी राय (उड़ीसा) : सभापति महोदय. मैं आपकी अनमति से उड़ीसा की गम्भीर खाद्य परिस्थिति पर आपका ध्यान खींचना चाहता हं। अध्यक्ष महोदय, 7 तारीख को य०एन० आई० की एक खबर निकली है। आप उड़ीसा के गवर्नर रह चुके हैं आपको उड़ीसा की आर्थिक स्थिति के बारे में पूरी जानकारी होगी। आज की जो खाद्य परिस्थिति है जिससे हजारों की तादाद में लोग भरने वाले हैं और मर रहे हैं उस की रपट आपकी खिदमत में पढ़ कर सुनाना चाहता हुं।

"About 40 per cent of the population cf Orissa is in the grip of severe drought and the rainfall during the last three months has been less than half of the average. A population of about 8 millions in nearly 15 gram panchayats are facing the natural calamity. About 50 per cent of the kharif crop has already

been lost in most of the districts. In June when agricultural operations started, the State had a meagre rainfall of 2.31 mms. In the following month when the operations should have been in full swing, the average rainfall was only 3.51 to 3.60 mms. as against the rainfall of 4.54 mms. in the first week of August in some parts of the State which raised hopes of rainfall that were short-lived."
