- (a) whether any plan has been formulated by Government for the development of Mayurbhanj, Kyonjhar and Sundergarh being tribal and very backward districts;
  - (b) if so, the progress made so far, and
- (c) if not, any effective steps are likely to be taken for the development of the tribal and backward classes inhabiting the region?

THE MINISTER OF TRIBAL AFFAIRS (SHRI JUAL ORAM): (a) to (c) The Ministry has adopted Tribal Sub Plan strategy for the States, including Orissa, with the objectives of (i) bringing the Scheduled Tribes on par with other sections of the society and (ii) protecting them from exploitation by various interest groups. The Tribal sub Plan covers the tribal areas of the State. Besides, there are 9 Integrated Tribal Development Agencies (ITDAs) functioning in these Districts. They are Baripada, Rairangpur, Karanjia, Kaptipada (in Mayurbhanj), Sundargarh, Panposh, Bonai (in Sundergarh), Keonjhar and Champua (in Keonjhar district). Under the schemes implemented by this Ministry and by the Ministry of Social Justice & Empowerment, no District-wise allocation of funds is made. Funds released to Orissa under the schemes during the last 3 years are given at Statement.
