Statement

The Delhi Administration has reported that 168 authorisations of fair price shops were cancelled during 1974, for irregularities such as variations in stocks, failure to maintain proper accounts, over-charging and registration of bogus cards by the fair price shop holders.

Construction of Roads in Coastal Villages of Kerala

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND

IRRIGATION (SHRI ANNASAHAB P. SHINDE) : (a) to (d) A statement is laid on the table of the Sabha.

Statement

The Government of Kerala in a letter dated 26-7-1974 forwarded a list of 55 items of work for new roads and spill over road works in coastal areas to be taken up under the proposed centrally sponsored scheme of "Development of infrastructure in coastal fishing villages." It was also mentioned in that letter that detailed project report for each item of road construction, accompanied by sketch showing alignment and importance of the road from fisheries point of view, etc. would be obtained. These are yet to be received from the Government of Kerala. It was, however, suggested by the State Government that provisionally a sum of Rs. 30 lakhs may be retained for release to the Government of Kerala, Rs. 25 lakhs for the spill over works and Rs. 5 lakhs for new works.

(c) The Centrally sponsored scheme "Development of infrastructure in coastal fishing villages" is being revised in consultation with the Planning Commission and the State Governments.

(d) It is now proposed that big fishing villages may be selected in maritime states and developed in an integrated manner by provision of arrangements for increasing production, roads, processing plants and effective marketing.
