THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI ANNASAHEB P. SHINDE) : (a) and (b) Owing to difficulties in getting foreign scientific journals from private firms, the Central Tuber Crops Research Institute, Trivandrum, had themselves purchased, during 1973 journals and magazines on single tender basis from Kerala University Cooperative Stores after paying advance subscription amounting to Rs. 44,000/-. This decision was taken by the Institute since the Kerala University and State Government Scientific Departments were availing of similar facilities offered by the Kerala University Cooperative Stores, and the Stores charged the Institute exchange rates as offered to the above organisation.

The Director, Central Tuber Crops Research Institute, approached the Indian Council of Agricultural Research,.

- in July, 1974, seeking standing approval of the Council to the above arrangements as also to the advance payment of subs-
- I cription, amounting to Rs. 51,740/- towards 90% of the cost of the journals during 1974 to the Kerala University Cooperative Stores.
