Workers' participation in the management of sick textile mills

*382. SHRI S. A. HASHMI: SHRI KASIM ALI ABID: SHRI MAQSOOD ALI KHAN:

Will the Minister of INDUSTRY AND CIVIL SUPPLIES be pleased to state:

- (a) whether Government are considering any proposal for the workers' participation in the management in respect of 103 sick textile mills taken over by Government recently;
- (b) whether Government propose to permit the employees to buy shares in these undertakings;
- (c) whether there is a proposal under Government's consideration to constitute any joint negotiating committee consisting of the representatives of the management and that of the workers for solution of the problems of mutual interest; and
- (d) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY SUPPLIES (SHRI AND CIVIL B. P. MAURYA): Provi-(a) participation at sions for workers' various levels of management are being considered for incorporation in a comprehensive Industrial Relations Bill which is being processed by the Ministry of Labour. As and when the Bill is enacted the question of workers' participation in the management of the nationalised textile mills would be decided in the light of the relevant provisions.

- (b) No such proposal is under consideration at present.
- (c) and (d) Workers' representatives are generally consulted on an informal basis on matters of mutual interest. There is no proposal at present to constitute any joint negotiating committee.
