Efforts should be made to make the AMIE Scheme self-supporting as far as possible at each centre. Wherever it is not feasible, the Central Government may grant annual subsidy to the extent of Rs. 6,500 for each centre limiting to the total grant-in-aid of Rs. 30,000 spread over a period of five years.

- (iv) The Committee strongly feels that the deficiencies in each institution be made up as early as possible. This is necessary to ensure to quality of products coming out of the institutions who are ultimately to occupy responsible supervisory positions in the mining industry.
- (v) The Diploma Course is being offered on the sandwich basis. The success of the programme lies in correlating theoretical instructions in the institutions with the practical training in the industry. The institutional training lacks in several ways. It is recommended that the entire programme of training be drawn up by a Committee consisting of representatives of the institutions and the industry. A post of Training-cum-Placement Officer be created at each institution. The Training Officer in the mine/Mine Manager should be responsible for the direction and supervision of the training programme. The training scheme should have a greater practical bias and be based upon the general principle that every future official should himself have performed every kind of underground job.

It is essential that the mine management should take the responsibility for providing suitable accommodation for the trainees placed at their mine for training.

A bus be provided at each institution for taking boys for excursions and training in the mines.

(vi) The institutions are generally following the scheme and syllabus for the diploma course formulated by the All India Council for Technical Education in 1956. The revised scheme and syllabus for the diploma course as prepared by the Joint Board in 1970 be circulated to all institutions for their guidance and adoption with such changes as may be necessary to suit the local conditions.

(vii) With a view to familiarise the students with the advances made in mining equipment and techniques, the list of models and equipment including mines safety equipment and apparatus be revised from time to time, say after every 5 years.

(vii) There was no standard list of Experiments/Sessional work being followed by the Institutions. The Committee has prepared a list of experiments/sessional work to be circulated to the institutions for their guidance.

(ix) With a view to update their know-ledge and keep themselves abreast with the advance in modern technology, the teachers including the Principals in diploma institutions should avail of the opportunity of training and experience under the "Quality Improvement Programme" launched by the Ministry of Education. They should also take advantage of summer schools and similar programmes offered by Indian Society for Technical Education and the Technical Teachers Training Institutes.
