DEPUTY MINISTER IN THE THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI): Sir, Chatis-garh area of Madhya Pradesh is almost completely served by the Bilaspur Division of South Eastern Railway. There are some factors which militate against the expeditious clearance of forest produce from the Chatisgarh area of Madhya Pradesh. Forest produce qualifies for movement in the lowest priority. There are heavy demands for the movement of steel, coal, cement, paper and foodgrains from th area, which constitute high priority ind have to be cleared preferentially. The disturbed law and order conditions ar>d the frequent disruptions to normal working on the South Eastern Railway right from December, 73 to May this year as a result of a series of go-slow and work-to-rale agitations, bundhs and power cuts had a crippling effect on the railway's capacity to meet the traffic demands in full.

Despite these constraints, every effort is being made to ensure the supply of the maximum number of wagons for the movement of forest produce, consistent with the
