Apart from training and exercises, the indigenous manufacture and purchases abroad, where necessary, are resorted to, in order to make the Navy an effective force.]

Legislation for Agricultural Labour

1149. SHRI KHUSRSHED ALAM KHAN:

Will the Minister of LABOUR be pleased to state:

- (a) whether there is a proposal under Government's consideration to bring a comprehensive legislation for the agricultural labour; and
- (b) if so, by when it is proposed to be brought?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR (SHRI BAL-GOVIND VERMA): (a) and (b) The Minimum Wages Act, 1948 and the Trade Union Act, 1926 are applicable to agricultural labour. The Agricultural Establishments are not excluded from the Payment of Bonus Act, 1965. Agricultural Farms run on commercial lines are also

covered under Industrial Disputes Act, 1947. The Employees' Provident Funds and Family Pension Fund Act, 1952 is applicable to agricultural labour engaged in specified plantations. Workers employed in farming by tractors or other mechanical power or by electricity are already covered by the Workmen's Compensation Act, 1923.

The Government have set up a Standing Committee on Agricultural Labour, interalia to review the existing legislative and other provision for the welfare of agricultural labour and to suggest a comprehensive legislation on the subject.
