the Railways will be adjusted on completion of the tour and the balance refunded to the party. This deposit is collected towards other charges that might accrue such as detentions to trains at the party's request at starting, intermediate or destination stations, etc.

(c) No concession as such was allowed to the Congress Party and the question of extending a similar concession to other political parties in the matter of running of special trains does not arise. Normal rules as applicable to public for running of such special trains will uniformally apply to special trains being organised by all political parties.]

Super express charge

THE DEPUTY MINISTER IN THE MINISTTRY OF RAILWAYS (SHRI BUTA SINGH): (a) The overall running time of 1 Up/2 Dn Howrah-Kalka Mail between Howrah and Delhi which was 22 hrs. 40 mts. in both directions previously

has now increased to 23 hrs. 50 mts. bet ween Howrah and Delhi and 24 hrs 15 mts. between Delhi and Howrah an the supplementary charge is still bein levied for travel by these trains.

(b) Except for 9 pairs of specified train the additional supplementary charge not levied for travel by other trains, is not proposed to abolish the supplementary charge for travel by 1 Up/2 Dn be ween Howrah and Delhi.
