1284. SHRI M. KADERSHAH: Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

(a) whether there is a proposal under Government's consideration to bring changes in the Central Wakf Board; and

(b) if so, what are the details thereof and if not, what are the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) and (b) Under the Wakf Act, 1954, there is

no Central Wakf Board but there is only the Central Wakf Council established under section 8A of the Act. It was last constituted on the 5th February, 1970, for a period of 5 years. Its reconstitution is still under the consideration of the Government.

(c) The following facilities are provided to the general public in the Willingdon Hospital, New Delhi:—

1. O. P. D. Services:—General public gynaecological patients are examined every day in the O. P. D. and maternity cases are examined in antenatal clinics twice a week in O. P. D.
2. Emergency services are provided for 24 hours for Gynaecological and Maternity cases and attended to by Resident Doctors on duty in Maternity
