Abolition of Examinations upto Matriculation

1286. SHRIMATI LEELA DAMODARA MENON: Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state:

- (a) whether it is a fact that Uttar Pradesh Government have decided to set aside the system of examination* upto Matriculation;
- (b) whether the Central Government have given any directions to the Uttar Pradesh Government in this regard; and
- (c) whether Government propose to give similar directions to all the States?

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION AND SOCIAL WELFARE AND IN THE DEPARTMENT OF CULTURE (SHRI D. P. YADAV): (a) to (c) It is learnt from the Government of U.P. that the system of examination upto matriculation has been suitably modified in respect of classes VI to IX and also class XI in all Government Higher Secondary Schools of U.P. Instead of promotion being determined exclusively on the performance in the Annual Examination it will now depend on four monthly tests, a terminal examination and the Annual examination. The weightage for these is 40, 20 and 40 respectively. Those who fail to qualify for promotion to the next class are allowed the facility of appearing in the supplementary examination in

June. Guardians are kept regularly informed about the progress of their wards.

The Union Ministry of Education had circulated a paper "Examination Reforms—A Plan of Action" to State Governments and Union territories for their guidance.
