Treatment of D.A. as part of pay

\*521. SHRI LOKANATH MISRA: SHRI K. P. SINGH DEO: SHRI M. P. VARMA:

Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

- (a) whether it is a fact that the Ministry of Finance agreed to the departmental action regarding treatment of Duty Allowance as part of basic pay, drawn by the staff in the Ministry of Shipping and Transport (Light-houses), which consequently resulted in anomalous position, vis-avis pay of senior employees in the same cadre and pay scale;
- (b) whether the matter was also taken up by the Ministry with the Comptroller and Auditor General of India in November, 1970; and
- (c) if so, what steps Government have taken to remove these anomalies?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI UMA SHANKAR DIKSHIT): (a) The term 'duty allowance' does not figure in the fundamental rules. In 1958, a special pay was sanctioned by Government to those Lower Division Clerks, who were incharge of the receipt and issue section of the headquarter office of the Director General of Lighthouses and Lightships. This was treated as part of their basic pay upto June 1963 as was permissible under the rules. officials, on promotion to the next higher grade, got the benefit of this special pay while their pay was refixed in the higher grade. On the other hand, employees who had not worked as in-charge of the receipt and issue section did not have this benefit on their promotion to the next higher grade and consequential refixation of pay.

(b) Pay fixation was done in accordance with the rules and the question of taking it up with the C.A.G. did not arise.
