## Seizure of Gold in Bombay

48. PROF. N. M. KAMBLE: SHRI K. N. DHULAP: SHRI R. D. JAGTAP AVER-GAONKAR:

Will the Minister of FINANCE be pleased to state:

- (a) The quantity of gold seized by the Central Excise and other authorities in Bombay during the last three years; and
- (b) the number of persons prosecuted in this connection and with what result?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (\$HRI PRANAB MUKHERJEE): (a) The quantity of gold seized by the Central Excise, Customs and State Government authorities in Bombay during the last three years under the Customs Act and Gold Control Act is given below:—

1972 . . . . . . 981 Kgs. 1973 . . . . . 575 Kgs. 1974 . . . . . 156 Kgs.

(b) 63 persons were prosecuted in this connection for the above three years. So far 26 persons have been convicted, 2 persons have been acquitted and 4 persons have been discharged. Prosecutions against 31 persons are still pending in the courts.
