Increase in Maintenance Allowance of students studying abroad

- (b) The Maintenance Allowance has been increased from US dollars 210 per month to US dollars 250 per month in case of studies in the U.SA. and Canada representing an increase of 19 per cent. In the case of studies in other countries, the allowance has been increased from Pounds 700/. (Pounds 750 in the case of students at Oxford and Camb ridge) to Pounds 900/-. representing an increase of about 29 per cent. The new scale_s will be introduced from 1st April, 1975.

State-wise distribution of loans sanctioned by the Industrial Finance Corporation of India to industrial concerns for setting up of new projects and for expansion, diversification of existing lines of production etc. in cooperative, private and public corporate sectors during the years 1972-73 and 1973-74 (April—March) is given in Annexures I and II respectively. [See Appendix XCI, Annex-ure Nos. 71 and 72].

The State-wise distribution of the financial assistance depends on location of industrial concerns assisted by the Corporation. The location of an industrial concern i_s indicated in the industrial licence where such licence is required; in other cases it is decided by the entrepreneur.
