Reserve rates for the disposal of land by D.D.A.

- what are the norms followed by the Delhi Development Authority for fixing the reserves rate for disposal of land in public auction or allotment to group hous ing schemes;
- (b) whether it is a fact that expenditure on items like levelling and dressing, roads and paths, storm water drains, sewerage, filtered water supply, street lighting, survey and demarcation of plots, L. T. distribu. tion, horticulture are taken into acount while fixing the land premium;
- (c) whether the reserve price also includes cost of acquisition and development of land used for parks, roads, open spaces meant for community etc. and a provision of 20 per cent over cost to meet unforeseen expenses; and
- (d) what are the details of other items of expenditure, if any, taken into account by the D.D.A. while fixing the initial reserve rate, or while revising the reserve rates?

THE DEPUTY MINISTER IN THE mental, administrative and interest charges MINISTRY OF WORKS AND HOUSING (SHRI DALBIR SINGH): (a) The reserve rate for developed plots is fixed by Delhi Administration on the basis of policies laid down by Government from time to time and is based on the cost of acquisition and development of land the additional charge and certain other charges. The price to be charged in respect of group-housing pockets, which are semi-developed, is 75 per cent of the reserve price as determined above.
