Working of C.M.D.A.

Will the Minister of WORKS AND HOUSING be pleased to refer to the reply to Unstarred Question 931 given in the Rajya Sabha on the 4th December, 1974 and state:

- (a) what are the reasons and factors responsible for the slow progress of the Calcutta Metropolitan Development Authority in completing the various schemes like water supply, sewerage and drainage, garbage disposal, environmental hygiene, housing and area development etc.;
- (b) by when the schemes are likely to be completed;
- (c) what are the reasons for the overhead expenses of Rs. 12.43 lakhs per month and break-up figures of overhead expenses, salary and perquites etc.; and
- (d) what are the details of the amount, year-wise, so far paid to the various contractors?

THE DEPUTY MINISTER IN THE MINISTRY OF WORKS AND HOUSING (SHRI DALBIR SINGH): (a) The implementation of some of the projects undertaken by CMDA could not make good progress due mainly to one or more of the following reasons:

- (i) Difficulty in timely procurement of essential materials/equipments.
- (ii) Multiplicity of implementing agencies.
- (iii) Shortage of trained and experienced personnel.
 - (iv) Engineers' Strike in 1974.
- (v) Delay involved in acquisition of land.
