Geological survey in Tripura

- 322. SHRI B. D. BARMAN: Will the Minister of STEEL AND MINES be pleased to state:
- (a) whether Government have decided to conduct a geological survey in Tripura;
- (b) if so, what are the details thereof; and
- (c) if not, what are the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND MINES (SHRI SUKHDEV PRASAD): and (b). Geological Survey of India is already engaged in carrying out systematic geological mapping prospecting for various minerals different parts of Tripura. To intensify these surveys, a separate Circle Office of GSI has been set up Agartala. Surveys carried out so far indicate the existence of Glass-sand, clay and good quality building stones. Geological surveys proposed to be carried out in Tripura by GSI during 1913 RS-5.

Attack on India House, New York

323. SHRI J. S. ANAND: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether it is a fact that a Zionist Organisation recently attacked India House in New York;
- (b) if so, what are the details thereof;
- (c) what action Government have taken thereon?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AF-FAIRS (SHRI BIPINPAL DAS): (a) Three youths created a fracas in India House, New York on 13th January, 1975. They are believed to be Jewish activists.

(b) On the 13th January, 1975, at 17.40 hours, immediately after closing hours, three young men believed to be Jewish activists entered India House-Headquarters of the Indian United Mission to the Nations and the Consulate General of India, under the pretext of seeking some information on educational matters. While the Security Guard on was trying to contact the Counseller (Education), the three youths spread themselves in the foyer, overturned and scattered consular furniture forms and publicity material that were lying on the open racks. Security Guard caught hold of one of the boys but the two other forcibly released him. One of them then threw an object, looking like a hand grenade, towards the Library which smashed the glass window pane, Examination revealed that the grenade was a hollow dummy. The three youths then ran out of the building The whole incident was over within The local security a few minutes.

authorities are investigating the matter and have also strengthened police protection for the Mission.

(c) All the Indian Missions abroad, especially those in the vulnerable areas, have been alerted to be vigilant and rigorously to observe security instructions separately issued to deal with such situations. Our Missions have also been advised to keep in touch with the local security agencies in this regard, whose responsibility it is for the security of our Missions and personnel posted there.

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI BIPINPAL DAS): (a) and (b). The World Hindi Convention adopted by acclamation a proposal asking for the acceptance of Hindi as one of the Official languages of the U.N. Delegates from 30 foreign countries parti-

cipated in the Convention. A list of these countries is at Annexure.

(c) to (e). Government is in the process of making an assessment regarding the possibility of Hindi being accepted as one of the languages of the U.N. Our Permanent Representative in New York has been instructed to consult with other delegations. Further action, as necessary, will be taken on the basis of this assessment.
