THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND MINES (SHRI SUKHDEV PRASAD): Yes, Sir.

- (b) According to the investigations carried out by the Geological Survey of India, the reserves of iron ore in Kozhikode district of Kerala are estimated at about 59 million tonnes with Fecontent ranging from 81.5% to 41.2%. Some tests will have to be carried out to determine the amenability of the ore to beneficiation.
- (c) A communication was received from the Government of Kerala in October, 1974, suggesting the establishment of a Steel Plant in Kerala; and
- (d) The establishment of a steel plant to utilize the fron ore deposits in Kozhikode district of Kerala can be considered only after the suitability of the ore for production of pellets sponge iron has been established and an overall assessment has been made of the area as a whole in the context of infrastructure facilities and economic feasibility, as well as availability of financial resources.

Sheikh Abdullah's Visits Abroad

- (a) what is the expenditure in terms of Indian currency and foreign exchange incurred on Sheikh Mohammad Abdullah on his visits to various countries during the last 10 years; and
- (b) whether these visits were officially sponsored or by any other Government agency and what were the facilities which were extended to him during these visits by Indian Missions abroad and whether such facilities and concessions have also been extended to other ordinary citizens of India and if so, what are the details thereof and the names of the persons to whom they were extended?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AF-FAIRS (SHRI BIPINPAL DAS): (a) Sheikh Mohammad Abdullah, accompanied by his wife and some others, went abroad for performing Haj and for visiting some countries of West Asia and Europe in 1965. Government sanctioned the usual foreign exchange of Rs. 1000 per head for Haj pilgrimage and Rs. 6,000 per head for visiting other countries.

(b) The visits were not officially sponsored. It is the practice of Indian Missions abroad to extend reasonable courtesies and assistance to Indian nationals, more so in the case of those who currently hold or have held in the past responsible positions in public life.
