*146. SHRI GANESH LAL MALI: Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

- (a) whether it is a fact that the prices of drugs can be reduced by 25 per cent by saving on advertising and packing;
- (b) if so, whether any steps are being taken in this direction; and
- (c) whether the National Convention of Economic Independence and Perspecti\e of Drug Industry has recommended the nationalisation of drug industry?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI K. R. GANESH): (a) and (b) Government of India have set up a Committee on Drugs and Pharmaceutical Industry under the Chairmanship of Shri Jaisukhlal Hathi, whose terms of reference, inter alia, include;

"To examine the measures taken so far to reduce the prices of drugs for the consumer and to recommend such further measures as may be necessary to rationalise the prices of basic drugs and formulations."

The Committee is expected to submit its report by April, 1975. It is expected that a more precise idea regarding the share of advertisement and packaging in the cost of drugs of different types would be available after this report is received. There is strong opinion in the country that there is scope to reduce the present prices by saving on advertisement and packing. The extent of reduction possible would be known on receipt of the report of the Committee. Such action as is necessary will be taken by Government in the light of the recommendations of the Committee.

(c) "The Convention has recommended that all units of the pharmaceutical and drug industry with foreign equity capibl participation should be nationalised.
