THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUSING (SHRI MOHAN DHARIA): (a) 1,651 out of which 1,607 are Government owned, 31 leased and 13 requisitioned.

- (b) An officer is eligible for allotment of a general pool residence, if he is employed in an office which has been declared as an eligible office under the Allotment Rules. Normally, an office, which is situated within the jurisdiction of the Calcutta Corporation and the Howrah Municipality and is part of the Secretariat or an Attached/Subordinate office of a Ministry of the Government of India, whose staff is paid from the Consolidated Fund of India and which has no separate pool of accommodation for its staff, is considered as an eligible office.

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (PROF. S. NURUL HASAN): (a) and (b) The Ancient Monuments and Archaeological Sites and Remains Act, 1958 empowers the Union Government to protect the mcnuments of national importance. At a meeting of the officers of the Delhi Administration and the Archaeological Survey of India it was felt that the responsibility for the protection of monuments of historic and artistic interest which have not been declared as monuments of national importance should be entrusted to the Delhi Administration and for this purpose fresh legislation be enacted, if necessary. The matter is being examined in greater details by the Delhi Administration.

THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUSING (SHRI MOHAN DHARIA):

#### Food Shortage in West Bengal

# 588. SHRI KALYAN ROY: SHRI BHOLA PRASAD:

Will the Minister of AGRICULTURE AND IRRIGATION be pleased to refer to the reply to Starred Question 448 given in the Rajya Sabha on the 4th December, 1974 and state:

- (a) whether Government are aware that an acute food shortage has developed in West Bengal because of total failure in the procurement drive;
- (b) what has been the procurement target in 1973-74 and 1974-75 and what has been the procurement during that period; and
- (c) what quantity of rice has been sent to that State from the Central Pool during last six months till the end of January, 1975.

THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI JAGJIVAN RAM): (a) Though the Food situation in West Bengal is not comfortable, it is not correct to say that the procurement drive in West Bengal has totally failed. The quantity of rice (including paddy in terms of rice) procured in West Bengal is more than what was procured during the corresponding period of last year.

(b) A target of 5 lakh tonnes of rice was fixed for the 1973-74 and 1974-75 seasons each against which a quantity of 1.59 lakh tonnes of rice was procured during the 1973-74 season. 1.36 lakh tonnes of rice has already been procured during the current season upto 22.2.1975 and the procurement is still going on. The procurement of rice during the corresponding period of the last season was only 1.06 lakh tonnes.

No other grain is procured in West Bengal.

(c) During the period 1-8-74 to 31-1-75 a total quantity of 1,51,300 tonnes of rice has been supplied to the state of West Bengal against an allotment of 1,68,000 tonnes from the Central Pool.
