THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI JAGJIVAN RAM): (a) An average price of Rs. 5340 per tonne was realised from the importing countries during the period 1st January to 20th February, 1975.

- (b) The wholesale prices of free market sugar in five important markets in the country have ranged from Rs. 417 per quintal to to Rs. 500 per quintal during this period.
- (c) The retail issue price of levy sugar throughout the country is Rs. 2 15 per kilogram. The ex-factory price, however, differs from zone to zone.

In respect of other categories of drugs the general practice is not to exceed the doses prescribed in pharmacopoeias.
