Santaldih Power Station

- 636. SHRI C. P. MAJHI: Will the Minister of IRRIGATION AND POWER be pleased to state:
- (a) whether it is a fact that the work on Santaldih thermal power station has not been completed so far; and
- (b) if so, the percentage of work so far completed and by when the remaining work is likely to be completed?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (PROF. SIDDHESHWAR PRASAD): (a) and (b) Santaldih thermal power station comprises the installation of four units of 120 MW each. The first unit has already been commissioned in October, 1973. In so far as the second unit is concerned, the civil works have almost been completed and the erection of the boiler and the turbine is in progress. This unit is expected to be commissioned in April, 1975.

The work on the erection of the third and fourth units is in various stages of progress and the expected dates of commissioning are June, 1976 and Decembei 1976, respectively.

Under this strategy, the State Governments were asked by the Planning Commission to prepare sub-Plans and submit them by the end of January, 1974. So far the sub-plans in re? pect of
