#### Labour Participation in Management

(a) whether Government have formulated any proposal regarding participation of the labour in the management of public sector undertakings under the Ministry of Steel and Mines; and

(b) if so, what are the details in this regard ?

**THE MINISTER OF STEEL AND MINES (SHRI K. D. MALAVIYA) :** (a) While no proposal as such for participation of labour in the management of public sector undertakings under the Ministry of Steel and Mines has been formulated, the association of labour with the management of these undertakings is generally sought to be achieved through joint consultations with workers in certain areas like welfare, grievances, safety, production etc. There is also a labour leader on the Boards of Directors of Coal Mines Authority and of Hindustan Copper Ltd.

#### Setting up of a Self-employment Cell in Defence Ministry

Will the Minister of DEFENCE be pleased to state :

(a) whether there is any proposal under Government's consideration to set up a self employment cell for the ex-servicemen in the Ministry of Defence; and

(b) if so, by when the proposed cell is to be set up and what are the details thereof ?

**THE DEPUTY MINISTER IN THE MINISTRY OF DEFENCE (SHRI J. B. PATNAIK) :** (a) and (b) In the Directorate General Re-settlement, functioning under the Ministry of Defence, a Cell was set up more than 2 years ago exclusively for looking after the self-employment of ex-servicemen. The Cell is headed by a Director in the rank of colonel and it consists of two Deputy Directors and two Assistant Directors who are assisted by 15 staff members.

The function of this Cell are :—

(i) Formulation and implementation of Self-employment Schemes;

(ii) Settlement in agriculture and small scale industries; and

(iii) Development of Ex-servicemen's Co-operatives and Ancillary Industries.

#### Scheduled Caste and Scheduled Tribe employees in the Indian High Commission, London
