THE MINISTER OF RAILWAYS (SHRI L. N. MISHRA): (a) to (c) A statement is laid on the Table of the Sabha.

Statement

The recent Railway strike continued for 20 days and about 5.5 lakh employees participated in it.

The following steps have been taken by the Government to avoid recurrence of any such strike on the Railways:

- (i) The two recognised Federations on Railways viz. the National Federation of Indian Railwaymen and the All India Railwaymen's Federation already enjoy negotiating facilities under Permanent Negotiating Machinery at different levels. In addition they have another forum viz. Joint Consultative Machinery for the ventilation and redressal of their genuine grievances.
- (ii) During the course of the negotiations which took place with these two recognised Federations on Railways, the Government accepted six demands- which are in the process of implementation.
- (iii) Provisions have been made to reward those railway workers who stuck to their post of duty in face of serious intimidation and physical assault and did not surrender to the threats of strikers.
- (iv) Government's policy to deal firmly wilh any acts of indiscipline and the enforcement of the principle of "No work—No pay", are designed to act as deterrents to any such strike.
