THE MINISTER OF SHIPPING AND TRANSPORT (SHRI KAMLAPATI TRI-PATHI): (a) and (b) The India-Pakistan-U. K. Continental Conference indicated their intention to increase freight rates with effect from the 1st October. 1974 because of increase in operational costs. The proposal was opposed by the All India Shippers Council on the ground that adequate justifications along with necessary cost data tfas not been furnished by the Conference. It was also pointed out that the shipping services provided by the Conference need to be improved. The proposal is going to be discussed further by the Conference with the All India Shippers Council some time in September. 1974.

(c) It is not possible to indicate the effect on India's export trade unless the quantum of the increase is known.

KARAN SINGH): (a) An agreement has been signed between the Government of India and the United Nations Fund for Population Activities CUNFPA) on the 18th July, 1974, according to which provision has been made for support of the order of \$40 million by the UNFPA to India for certain activities for five years.

(b) A statement is laid on the Table of the Sabha.

The UNFPA assistance of \$40 million may be utilised for the following areas of activities:—

- 1. Delivery of Family Planning services.
- 2. Contraceptive Supplies and their rftamifacture.

- 5. Introduction of Health Education including Family Life Education in schools.
- fi. Expansion of Documentation facilities.

of the project, as it takes time to improve productivity of milk in milch animals. The Indian Dairy Corporation, which is the implementing authority for the Project, has been advised to concentrating on milk production enhancement programmes and the organization of the producers into cooperative societies and milk unions.
